

## CIVIL RIGHTS CONGRESS

The Civil Rights Congress was founded in Detroit, Michigan in 1946. It was formed from a merger of three groups, the International Labor Defense, the National Federation for Constitutional Liberties, and the National Negro Congress. Its Director was William L Patterson.


One of the most notable things the CRC did was present the petition of We Charge Genocide: The crime of government against the Negro people. This petition was written by the CRC and presented to the United Nations at meetings in December 1951.

This document pointed to the definition of genocide stated by the UN convention of the prevention and punishment of genocide, as any acts committed with the intent to destroy a group in whole or in part.

The US state department forced William L.

Patterson to surrender his passport after presenting the petition to the UN. The petition was also presented through Paul Robeson, who together with others signed the petition and handed the document to UN officials in New York City.

The CRC ultimately disbanded in 1956, but helped play an important role in the overall civil rights movement.



# History of US Communists defending Civil Liberties

JOHN ABT was a lawyer for CPUSA leadership, which was indicted by the US government and imprisoned for "subversive activities" during the McCarthy period of the early 1950s.

erizabeth Gurley Flynn was a labor organizer, was on the central committee of the CPUSA and was on the national board of the American Civil Liberties Union (ACLU). She was expelled from the organization because of her involvement with the communist movement.

PAUL ROBESON was an all-star football player in college and baritone singer in Hollywood, but his passport was taken away from him by the US government for speaking out in favor of the Soviet Union and being a communist.

HENRY WINSTON was the National Chair of the CPUSA and was sent to prison under the Smith Act. He was blinded in prison, and said "They robbed me of my sight, but not my vision."
